As GB of KSS have decided to go for the elections for the term 23-26 for Collegium Members and Governing Body as notified below:

- Election to Collegium on 10th Dec 2023. (Stage I)
- Election to Governing Council / Body on 24th Dec 2023 (Stage II)

Stage I ELECTION FOR COLLEGIUM: -

The electorate for the collegium will be the KSS life members residing in the geographical area of the electoral college from which the member is elected. The electoral college is defined in the Annexure III.

There will be 67 Electoral Colleges. Each Electoral College will comprise of the life members of the Samaj living in a particular geographically homogenous area.

One Collegium member will be elected from each Electoral College.

Stage II ELECTION FOR GOVERNING BODY & OFFICE BEARERS :-

All the members elected to Collegium will form the electorate for the election of Governing Body and office bearers. The office bearers of the Governing Body of the Samaj will be as follow:

- III. General Secretary
- IV. Joint Secretary
- V. Treasurer
- VI. Governing body members

As per the Haryana govt order No.S.O.51/HAI/2012/S.87/2012 / No. 8/1/2018-4IB-II.— The 22nd June, 2018 and further amendments from time to time “ Regulations & Procedure for the Conduct of Elections to the collegium” it may be noted that only “ members” as defined in List of members of the Society under section 18(3) of the Haryana Registration and Regulation of Societies Act, 2012”. & List of members and changes therein during year 2022 - and who have paid the membership on or before the date of notification issued by the KSS (i.e., on or before 01.10.2023) shall be entitled to contest the KSS collegium elections, propose or second candidates and cast vote. The list of life members is displayed on the notice board of KSS as well.
